Thank you for your letter of the 16th, your reference H/272 and for replying so promptly. The photographs I asked you for are intended to form part of an exhibition on golf in the Netherlands which will be held in the Spring and Summer of 1982 under the motto 'COLF-KOLF-GOLF, from a game in the Middle-Ages to a modern sport'. The exhibition will be on view in Bergen op Zoom, Ghent, Antwerp and Amersfoort. It will show many historic paintings and objects which have never been on view before and hopefully be accompanied by an illustrated catalogue with an extensive introduction in Dutch as well as in English with French and German resumes. In fact the whole thing should be quite attractive when it is ready. This particular patent is very interesting because of its reference to the import of balls. These balls came from the Netherlands(there were no other production centres of this type of ball at that time) and quite a bit has been found out about them. The exhibition will even show two sets of 17th and 18th century ball-making tools. Obviously we are trying, as much as possible, to show the original documents and objects, but we did not dare to ask the Scottish Record Office for a loan of the origonal register! This being so the closer the photographs can come to the original size of the folio's in question, the better. The should be glossy by preference. A transcript we have. Not knowing the size of the register in question I think the maximum size of the photographs should be 18x24 cms. I would ask you to let me have two copies of each of the three photographs. If permission is needed to show the photographs at the exhibition may I ask for that permission herewith. It goes without saying that they will be accompanied by a notice of their provenience when on view. Please let me know about the total cost of making and mailing the photographs which I shall then remit to you. Thanking you in advance for your courtesy in this matter

Dear Mr van Hengel

Miss Young has passed on your letter of 25 January relating to your request for photographs of the entry in PS1/87.

The register page measures  $12 \times 7\frac{1}{2}$  inches (30 cm x 19 cm), and I recommend that the photograph size should be  $12 \times 10$  inches (30 cm x 25.5. cm) to allow the pages to be reproduced actual size. Because of the clarity of the writing, a small reduction to produce a print of  $10 \times 8$  inches (25.5 cm x 20 cm) would be possible if the space available for display at the exhibition should be restricted in some way, but on balance I suggest that it would be preferable to supply prints which would give full size renderings of the text.

Accordingly, I have quoted for the supply of two 12 x 10 inch prints of each of the three pages. The cost is £18.73, fully inclusive of our handling charge and postage, and I shall be pleased to put the work in hand on receipt of your remittance. Payment should be made in sterling by International Money Order or cheque drawn on a British account, made payable to the Scottish Record Office.

In displaying the photographs, perhaps you would include the full reference to the item in the caption and quote this office as the source.

Incidentally, you may find it useful to know that the museum at North Berwick, some 20 miles from Edinburgh, has maintained an attractive display of golfing relics because of local interest. I suggest that you might write to the Honorary Curator, Burgh Museum, North Berwick, East Lothian.

Thank you for your letter of 8 October.

The St Andrews kirk session records are in local custody, and any enquiry regarding them should be made to Mr Charles Armour, 17 Queens Gardens, St Andrews KY16 9DA. However, the records for the period 1559-1600 were published by the Scottish History Society in two volumes in 1889 and 1890, covering the years 1559-82 and 1582-1600 respectively. I have had a quick look through these without locating the entry in question. The various histories of St Andrews which we have here do not help.

Since you do not know the date of the item, you might try the archivist at St Andrews University, Mr Smart, before approaching Mr Armour for a search to be made. If you give Mr Smart the full background to your own information, he may be able to develop this from some other source. His address is Keeper of Muniments, University Muniments, North Street, St Andrews.
