## Very fine early golfing painting - 1613 Wybrand-Simonsz De Geest

The above oil painting is fully authenticated, with a good provenance and dated 1613. It represents a  $4\frac{1}{2}$  year old Dutch boy wearing a charming russet smock with a beautifully embroidered, white lace trimmed pinafore and ruff. He is depicted standing on a pink tiled floor and is holding what looks to be a No. 5 iron ready to deal appropriately with his hand-stitched golf ball.

A photograph is enclosed, but of course ideally the picture should be seen as the colours are delightful. The measurements are height 110 cm. and width 80 cm. and a purchase could be made at \$42,000, subject to availability.

The painting is very similar to the Elizabethan portraits you see of Sir Francis Drake and Sir Walter Raleigh etc. of exactly this period.

Wybrand-Simonsz De Geest Leuwarden 1590 - 1659

A Dutch portrait painter who later lived in Antwerp. He was the son and pupil of a painter from Lourain, Syrian de Geest. In 1613 van Geest worked in Utrecht with the painter Abraham Bloemaert; he then travelled to Belgium, France and finally visited Rome, where he stayed for some years. On his return to Holland he settled in Amsterdam, painting in the manner of Jan van Ravestyn and Paulus Moreelse. Examples of his paintings are in the museums of Haarlem, Amsterdam, Stuttgart and Lille.

Wybrand Simonsz. de GeestI.Painter pf portraits, born at Leeuwarden in 1590 or 1592, died there 1659, son and pupil of Symon de Geest, a painter from Antwerp who settled in Leeuwarden. In 1613 Wybrand was a pupil of Abraham Bloemaert in Utrecht. He visited Belgium and France and worked for 4 years in Rome. In the group there he acquired the nickname' The Frisian Eagle'. After his return to Leeuwarden he married Hendrikje Ulenburgh, sister of Saskia Ulenburgh (born 1612) who became Rembradt's wife and who was educated by Wybrand after 1624, she being a full orphan. It appears that Wybrand lived in Amsterdam for a time. As a rule however he lived in Leeuwarden where he became

As a rule however he lived in Leeuwarden where he became the court painter to the 'Lord Lieutenant' (a Nassau prince). His son Julian and his grandson Wybrand II also became painters.

He is an excellent painter of portraits of the old school. He shepherdesses remind one of Paulus Moreelse. Houbraken (I.,149) mentions Jacobus Potma as a pupil of him.


