
Dear Mr. van Hengel,

Our painting is one of a pair, the child in the other painting carrying a basket of cherries instead of a golf club.

Dear Mr. Smith,

This is to thank you for your letter of the 2nd. It was very kind of you to write. The story about your pictures sounds very interesting. Let me begin by saying that there is absolutely no doubt as to the date, 1595, of the picture as printed in Country Life. Not only because the date is quite clearly marked on the painting but also, and even more so, because of the style of the costume of the young man and the golf implements he holds in his hands. Sartorial fashions in the 16th and 17th century changed even more rapidly than they do today. This also applied to children's clothes. If the picture in Country Life would have been painted in 1695 it would have been a very odd anachronism in every respect.

Turning to your paintings: I would much appreciate receiving a photograph of both of them. It may well be that I can provide you with a bit of background to both of them.

Children in those days were nearly always painted with an object on both hands. This made them stand more or less still while posing. For your information I am enclosing three photographs. One of them is at my home course in Zandvoort and depicts a boy and a girl, the boy holding a golf club and the girl holding a branch of cherries.

The other two belong to a set of five family portraits hanging in the Reformed Orphanage in the city of Enkhuizen. All of them were painted by an anonymous painter in 1612. The boy was then 7 and holds a club and a ball, the girl holds a basket of cherries and a bird. She was then 4 years old. Both of them were children of the Slijper family, a well known family of magistrates in that city.

As you can see not only the club and ball but also the cherries were quite popular on paintings in that period.


Dear Mr. van Hengel,



GETTING TO SHOTTESBROOKE FROM THE M4, COMING FROM LONDON

---

- Take exit 8/9 marked "Henley, Oxford A423(M) Maidenhead"
- The slip road at this exit takes you up onto an elevated roundabout over the motorway
- From this roundabout take "Henley Oxford A423(M)"
- After half a mile on A423(M) take exit marked White Waltham
- This exit brings you immediately to a T junction: turn right (usually signposted to White Waltham).
- After 100 yards, at a cross roads, turn left (signposted to White Waltham)
- After 200 yards, bend right at fork (signposted to White Waltham)
- You should now be driving along an open lane, with a large arable field on your right
- After 6/10 of a mile, at a T junction, with modern houses behind a boarded fence opposite you, turn left.
- After 4/10 of a mile, in built-up area, bend left, following the main road, which takes you past airfield on your right, to White Waltham village
- Drive through White Waltham village, still on same road
- At the end of the village street, with war memorial and cricket ground ahead, bend left, keeping to main road.
- With cricket ground now on your right, keep to main road for 600 yards, and at road junction with a mass of signs, our red brick lodge with semicircle of gravel is on your right.
- Turn in here (spire visible ahead) over cattle grid, and follow the drive, past the church. Do not open the iron gate: if it is shut (which it usually is), fork right and continue with iron railings on your left.







Dear Mr. Smith,

Thinking back to your kind reception in December I have been doing some research on the paintings of the 'Cherry Boy' and the 'Golf Boy' brothers of 1594 and 1596. I am by now pretty satisfied that they were painted by Adriaen van der Linde.

This painter, hailing from Bruges in Belgium, moved to Leeuwarden in Friesland before 1595. He was married to Janneke Farnese from Tiel in Guelderland. In 1605 they moved to Bolsward in Friesland where he died on the 8th April 1609. The inscription on the tomb of the couple in Bolsward reads: Ao 1609 den 8. Aprilis is gherust Mr. Adriaen van der Linde, schilder van Brugge, hier begraven. (On the 8th of April came to rest Master Adriaen van der Linde, painter from Bruges, buried here.)

From a lawsuit in 1595 touching on the supply of panels and picture-frames it may be seen that he was a well-known portrait-painter, because strangers came to sit for him. Also he was well known in the County of Holland where he probably painted as well.

A child's portrait, very similar to your 1594 one, is in the Fries Museum at Leeuwarden. It is also on a panel, bearing the date 160.. in the painting and measuring 91x62,5 cms, almost identical with both your paintings: 91,5x67 and 96,5x67 cms.

Van der Linde certainly had a taste for that size of panels. Apart from the abovementioned ones there is another one dated 1592, measuring 96x69,5 cms and depicting a 2 year old child of the Frisian Sirtema van Groenstins family and some others measuring 96x80(1595), 96x80(1595) and 93x73(1596). It may well be that these were the panels of the court case in 1595.

Your paintings clearly date from his Leeuwarden period. It is however difficult to say whether the two brothers were Frisians or from Holland or elsewhere, seeing van der Linde's fame.

Details about Adriaen van der Linde may be found in: Dr. A. Wassenbergh, De Portretkunst in Friesland in de zeventiende eeuw (The art of portraying in Friesland in the 17th Century) published by N.V. Uitgeversmaatschappij De Tijdstroom at Lochem in 1967, pages 19-21.

I am writing these details to you since information on Adriaen van der Linde is hard to come by. Friesland was an isolated part of the world at that time.

Kindly remember me to Mrs. Smith and your son.
