My Dear Monk,

Yours of the 7th and 8th inst. to hand; please pardon me for not having replied earlier as I have been making the necessary enquiries which now permit me to write you as follows:

Re "HARLEQUIN" SPOONS

Certainly, players to qualify for these must use the "HARLEQUIN" Ball, either the GRIP MESH, RECESS or SUPER. I think if you again read the handbills recently sent you, you will find this is distinctly stated. Bye the way, we know of many instances of players using the "DOT & DASH" to send in a claim for one of these spoons, and although we cannot recognise any such performance in the way of a sppon, we always meet the case by giving a Prize of a few golf balls or by having the particular ball in question mounted in Silver; this of course can hardly apply to foreign countries on account of the trouble with the customs and the cost of sending backwards and forwards. However, bear it in mind that we are always anxious to hear of phenomenal scores etc. made with our balls and invariably recognise it in some way.

Now about your proposed Championship; I have recovered from the shock - which after all was not very great - and in the first place allow me to congratulate you on being second in the Open. This I was not aware of; I am very pleased you have such a high opinion of the SUPER.

Now I take it for granted that you have some sort of an association amongst you Professionals in Holland and that it is by this association you have been authorised to do the needful, somI would like you to put the following proposal before them.

I am willing - provided it meets with the approval of what we will

call The Dutch - or Netherlands - Professional Golfers Association to recommend to my firm (and I know that my recommendation is usually
carried through) that they hand over to your Association a Cup
to be inscribed as the HARLEQUIN CUP and underneath The Dutch - or
Netherlands - Professional Championship. This Cup would be for annual
competitions amongst the Profess attached to any Golf Club in Holland
and it would be held by the Club to which that Professional was
attached for one year, the winner being presented with a replica for
his own retention. We would not go so far as you do by saying that
the players must use our Ball, but we would be willing to provide an
annual prize - until further notice - of £10. to be presented to the
winner of the Cup provided he played with the "HARLEQUIN" Golf Ball.
An important condition in connection with this offer is, that no
other Golf Ball manufacturers name - or brand - shall appear in this
Competition although we have no objection to a Prize List being
provided by any other firm to be given in connection with the same
competition.

Please let me have your views and would it be possible to run the competition this season for the first time?

What number of entries would you anticipate getting?

When and where would you hold the competition, as if I am anywhere near I would very much like to be present?

What is the actual inscription you would like on the Cup, and would it be in English or Dutch?
