Dear Monk,

Yours of the 11th inst just to hand and I hasten to reply to you as follows:-

I think for my purpose (confidentially) this name will be most suitable and I would like you to try and prevent use of the word 'Alliance' in connection with the Competition.

You see it has not altered my intention in the least, and the CUP and prize is still forthcoming.

Now Monk I am of rather a retiring nature and I do not want you to arrange that I hand over the CUP to the winner at the end of the Competition, I would much rather, if you would make arrangements, for some influential lady or gentleman Golfer who is certain to
