Dear Sir,

We beg to confirm the verbal conversation made with our **Mr. Miller** in reference to the "HARLEQUIN" Cup presented to your association at HENGLO on the 24th inst.

We are sending this letter in duplicate and if you agree, we will be obliged if you will sign the attached copy provided for the purpose as a receipt of the Cup and conditions.

## "HARLEQUIN" CUP & CONDITIONS

**1.** The "HARLEQUIN" CUP is presented by the Harlequin Ball & Sports Co. Ltd. to the Netherlands Professional Golfers Association for Annual Competition amongst members of that body for the purpose of encouraging Golf in Holland.

**2.** Each year until further notice the Harlequin Ball & Sports Co. Ltd. will present a replica of the "HARLEQUIN CUP" which will become the sole property of the Winner - the original Cup being returned to the Secretary of the Association each year, two days before the advertised date on which the Competition is to be held. (Note - where it is possible we would like the original to be held for the year by the Club for which the Winner is the Professional.)

**3.** Players entering this Competition may play with any make of Ball they choose as it is not a condition that our manufacture alone should be used, although we will give the sum of **£10.** to the winner each year provided he is playing a ball of our brand and manufacture.



4. It is clearly understood that although Prize Money may be accepted from any other Golf Ball or Accessories manufacturer for this competition, the name of any such donor will not be publicly used in connection with the competition but that the title of the competition will remain "THE NETHERLANDS PROFESSIONAL CHAMPIONSHIP" (HARLEQUIN CUP) under all conditions.

5. In the event of the Championship being abandoned, the Cup will - after remaining a year with the last winner - be returned to the manufacturer's agent - MR.D.MONK. Hilversum. for safe custody or disposal.
